Policy 04.01.301 mandates zero tolerance toward all forms of sexual abuse and sexual harassment. The written policy outlines the agency's approach to preventing, detecting, and responding to sexual abuse and sexual harassment.

The agency's organizational chart reflects the PREA Coordinator position in the upper level of the agency hierarchy. The PREA Coordinator verified during interview that he has sufficient time and authority to develop, implement, and oversee agency efforts to comply with the PREA standards in all of its facilities.

The facility's organizational chart reflects a designated a PREA compliance manager. The PREA compliance manager verified during interview that she has sufficient time and authority to coordinate the facility's efforts to comply with the PREA standards.

Based on the review of policy, documentation and interviews, the facility meets compliance with this standard.

115.313 Supervision and monitoring

Auditor Overall Determination: Meets Standard

Auditor Discussion

The agency submitted a 2023 Staffing Plan, 2023 Leave Relief Schedule, and a Security Roster to validate that the agency ensures that each facility it operates shall develop, implement, and document a staffing plan that provides for adequate levels of staffing, and, where applicable, video monitoring, to protect residents against sexual abuse. In calculating adequate staffing levels and determining the need for video monitoring, facilities take into consideration: (1) Generally accepted juvenile detention and correctional/secure residential practices; (2) Any judicial findings of inadequacy; (3) Any findings of inadequacy from Federal investigative agencies; (4) Any findings of inadequacy from internal or external oversight bodies; (5) All components of the facility's physical plant (including "blind-spots" or areas where staff or residents may be isolated); (6) The composition of the resident population; (7) The number and placement of supervisory staff; (8) Institution programs occurring on a particular shift; (9) Any applicable State or local laws, regulations, or standards; (10) The prevalence of substantiated and unsubstantiated incidents of sexual abuse; and (11) Any other relevant factors. This was verified in interviews with the superintendent and PREA compliance manager. The auditor observed adequate staffing levels on all shifts during the site review.

Per the PAQ and interview with the superintendent, there has been no deviations to the staffing plan.

The superintendent stated during interview that the facility maintains staff ratios of a minimum of 1:8 during resident waking hours and 1:16 during resident sleeping hours, except during limited and discrete exigent circumstances, which would be fully documented. Only security staff are included in these ratios. The facility is required to maintain the staffing ratios listed above to achieve compliance. The auditor observed adequate staffing levels on all shifts during the site review.

2023 PREA Staffing Plan and an interview with the PREA coordinator confirm that once every year the agency, in collaboration with the agency's PREA coordinator,

reviews the staffing plan to see whether adjustments are needed to: (a) the staffing plan; (b) prevailing staffing patterns; (c) the deployment of monitoring technology; or (d) the allocation of agency or facility resources to commit to the staffing plan to ensure compliance with the staffing plan.

01.02.103 policy describes having intermediate-level or higher-level supervisors conduct and document unannounced rounds to identify and deter staff sexual abuse and sexual harassment. The policy and practice are implemented for night shifts as well as day shifts. The policy prohibits staff from alerting other staff members that these supervisory rounds are occurring, unless such announcement is related to the legitimate operational functions of the facility. This was confirmed by review of unscheduled inspection reports and logbook entries for all shifts and interviews with intermediate and higher-level staff who conduct the unannounced rounds.

Based on the review of policy, documentation, site review and interviews, the facility meets compliance with this standard.

115.315 Limits to cross-gender viewing and searches

Auditor Overall Determination: Meets Standard

Auditor Discussion

05.01.302 policy reflects that the facility always refrains from conducting any cross-gender strip or cross-gender visual body cavity searches, except in exigent circumstances or by medical practitioners. During the site review, the auditor did not observe any cross-gender searches being conducted. Per the PAQ, in the past 12 months, there have not been any cross-gender strip or cross-gender visual body cavity searches of residents.

05.01.301 policy and interviews with random staff and residents, state that the facility always refrains from conducting cross-gender pat-down searches in non-exigent circumstances.

05.01.301 policy requires that all cross-gender strip searches, cross-gender visual body cavity searches, and cross-gender pat-down searches be documented and justified. Per the PAQ, there have not been any cross-gender pat searches conducted.

05.01.301 policy enables residents to shower, perform bodily functions, and change clothing without nonmedical staff of the opposite gender viewing their breasts, buttocks, or genitalia, except in exigent circumstances or when such viewing is incidental to routine cell checks. The facility requires staff of the opposite gender to announce their presence when entering a resident housing unit. During the site review, the auditor verified that announcements were being made and that knock and announce signs were displayed. This was confirmed during interviews with random staff and residents.

Policy 05.01.301 states that the facility always refrains from searching or physically examining transgender or intersex residents for the sole purpose of determining the resident's genital status. If a resident's genital status is unknown, the facility determines genital status during conversations with the resident, by reviewing medical records, or, if necessary, by learning that information as part of a broader medical examination conducted in private by a medical practitioner. This was confirmed through interviews with random staff. At time of audit, the facility did not have any transgender or intersex residents to interview.

By review of training logs and curriculum and interviews with random staff, the facility trains security staff in how to conduct cross-gender pat down searches in a professional and respectful manner, and in the least intrusive manner possible, consistent with security needs. The facility also trains security staff in how to conduct searches of transgender and intersex residents in a professional and respectful manner, and in the least intrusive manner possible, consistent with security needs. The curriculum also restricts staff from conducting any form of cross-gender searches.

Based on the review of policy, documentation, site review and interviews, the facility meets compliance with this standard.

115.316

Residents with disabilities and residents who are limited English proficient

Auditor Overall Determination: Meets Standard

Auditor Discussion

04.01.111 policy explains that the agency takes appropriate steps to ensure that residents with disabilities (including, for example, residents who are deaf or hard of hearing, those who are blind or have low vision, or those who have intellectual, psychiatric, or speech disabilities), have an equal opportunity to participate in or benefit from all aspects of the agency's efforts to prevent, detect, and respond to sexual abuse and sexual harassment. Such steps include, when necessary to ensure

effective communication with residents who are deaf or hard of hearing, providing access to interpreters who can interpret effectively, accurately, and impartially, both receptively and expressively, using any necessary specialized vocabulary. In addition, the agency shall ensure that written materials are provided in formats or through methods that ensure effective communication with residents with disabilities, including residents who have intellectual disabilities, limited reading skills, or who are blind or have low vision. The facility submitted Language Line Interpreter Information, DJJ Youth Orientation Handbook in Spanish, Pere Marquette Youth Guidebook in Spanish, PREA posters in Spanish and English, ADA staff training records, ADA training curriculum, and mandated reporter training curriculum to support compliance with this standard. This was confirmed by interviews with the agency head and residents with a disability. At time of audit, there were no residents with limited English proficiency to interview. During the site review, the auditor tested the facility's process for securing interpretation services on-demand using Language Line Services and was able to determine that accessing the language line worked properly. Persons confined in the facility do not need to self-identify to access interpretation services. Informal conversations with staff and persons confined in the facility regarding accessibility of interpretation services when needed confirmed compliance with this standard.

04.01.111 policy and 05.05.101 policy states that the agency takes reasonable steps to ensure meaningful access to all aspects of the agency's efforts to prevent, detect, and respond to sexual abuse and sexual harassment to residents who are limited English proficient. These steps include providing interpreters who can interpret effectively, accurately, and impartially, both receptively and expressively, using any necessary specialized vocabulary. This was confirmed by review of the DJJ Youth Orientation Handbook, PREA posters in English and Spanish, Mandated Reporting Form, and the Youth Orientation Handbook in Spanish, and interviews with residents with a disability. At time of audit there were no residents who were limited English proficient to interview.

04.01.111 policy explains that the agency always refrains from relying on resident interpreters, resident readers, or other types of resident assistants except in limited circumstances where an extended delay in obtaining an effective interpreter could compromise the resident's safety, the performance of first-response duties under §115.364, or the investigation of the resident's allegations. This was confirmed through review of the mandated reporter form, PREA posters in English and Spanish, and through interviews with random staff and residents with a disability. At time of audit there were no residents who were limited English proficient to interview.

Based on the review of policy, documentation, site review and interviews, the facility meets compliance with this standard.

115.317	Hiring and promotion decisions

01.02.107 policy and 03.02.105 policy prohibits hiring or promoting anyone who may have contact with residents, and prohibits enlisting the services of any contractor who may have contact with residents, who: • Has engaged in sexual abuse in a prison, jail, lockup, community confinement facility, juvenile facility, or other institution (as defined in 42 U.S.C. 1997); • Has been convicted of engaging or attempting to engage in sexual activity in the community facilitated by force, overt or implied threats of force, or coercion, or if the victim did not consent or was unable to consent or refuse; or • Has been civilly or administratively adjudicated to have engaged in the activity. This was confirmed through staff file reviews.

03.02.105 policy and 03.02.108 policy require the consideration of any incidents of sexual harassment in determining whether to hire or promote anyone, or to enlist the services of any contractor, who may have contact with residents. This was verified through interview with HR staff.

03.02.105 policy and 01.02.107 policy require the consideration of any incidents of sexual harassment in determining whether to hire or promote anyone, or to enlist the services of any contractor, who may have contact with residents. This was confirmed through staff file reviews and interview with HR staff.

01.02.107 policy requires that a criminal background records check be completed, and applicable child abuse registries consulted before enlisting the services of any contractor who may have contact with residents. This was confirmed through staff file reviews and interview with HR staff.

01.02.107 policy requires that either criminal background records checks be conducted at least every five years of current employees and contractors who may have contact with residents or that a system is in place for otherwise capturing such information for current employees. This was verified through review of staff files and 5-year background check samples. This was confirmed through interview with HR staff.

Interviews with HR staff confirm that the agency asks all applicants and employees who may have contact with residents directly about previous misconduct in written applications or interviews for hiring or promotions and in any interviews or written self-evaluations conducted as part of reviews of current employees. The agency also imposes upon employees a continuing affirmative duty to disclose any such misconduct.

03.02.108 policy states that material omissions regarding such misconduct, or the provision of materially false information, shall be grounds for termination.

HR staff stated that the agency will provide information on substantiated allegations of sexual abuse or sexual harassment involving a former employee upon receiving a request from an institutional employer for whom such employee has applied to work.

Auditor Overall Determination: Meets Standard Auditor Discussion Agency head and superintendent stated during interviews that the agency or facility has not acquired a new facility or made a substantial expansion or modification to existing facilities since the last PREA audit. This was confirmed through review of a submitted memo. Agency head and superintendent stated during interviews that the agency or facility has not installed or updated a video monitoring system, electronic surveillance system, or other monitoring technology since the last PREA audit. Based on interviews and documentation, the facility meets compliance with this

115.321 Evidence protocol and forensic medical examinations Auditor Overall Determination: Meets Standard **Auditor Discussion** The agency/facility is responsible for conducting administrative sexual abuse investigations (including resident-on-resident sexual abuse or staff sexual misconduct). The agency/facility is not responsible for conducting criminal sexual abuse investigations (including resident-on-resident sexual abuse or staff sexual misconduct). Department of Children and Family Services and Illinois State Police has responsibility for conducting either administrative or criminal sexual abuse investigations. 04.01.302 policy, 01.12.112 policy, and 01.12.123 policy addresses when conducting a sexual abuse investigation, the agency investigators follow a uniform evidence protocol. This was verified through interview by random staff. 04.01.302 policy, 01.12.120 policy and 01.12.112 policy states that the protocol shall be developmentally appropriate for youth and, as appropriate, shall be adapted from or otherwise based on the most recent edition of the U.S. Department of Justice's Office on Violence Against Women publication, "A National Protocol for Sexual Assault Medical Forensic Examinations, Adults/Adolescents," or similarly comprehensive and authoritative protocols developed after 2011.

Per the PAQ, 04.01.302 policy and forensic examination list, the agency offers all residents who experience sexual abuse access to forensic medical examinations at

an outside facility, without financial cost, where evidentiarily or medically appropriate. Such examinations are performed by Sexual Assault Forensic Examiners (SAFEs) or Sexual Assault Nurse Examiners (SANEs) in facilities notated on the list. Facility medical staff are not trained to conduct forensic examinations.

The facility attempts to make a victim advocate from a rape crisis center available to the victim, in person or by other means. This was verified through a review of documented efforts to secure a MOU, MOU with Metro East, and a MOU with Call for Help. If and when a rape crisis center is not available to provide victim advocate services, the facility provides a qualified staff member from a community-based organization or a qualified agency staff member. This was verified through a review of professional licensures. This was confirmed through interviews with the PREA compliance manager and a resident who reported sexual abuse.

04.01.302 policy states that if requested by the victim, a victim advocate, or qualified agency staff member, or qualified community-based organization staff member accompanies and supports the victim through the forensic medical examination process and investigatory interviews and provides emotional support, crisis intervention, information, and referrals. This was confirmed through interviews with the PREA compliance manager and a resident who reported sexual abuse.

01.12.135 policy states that the agency is not responsible for investigating criminal allegations of sexual abuse and relies on another agency to conduct these investigations.

Based on the review of policy, documentation and interviews, the facility meets compliance with this standard.

115.322 Policies to ensure referrals of allegations for investigations

Auditor Overall Determination: Meets Standard

Auditor Discussion

The 04.01.302 policy and the 01.12.120 policy ensure that an administrative or criminal investigation is completed for all allegations of sexual abuse and sexual harassment. This was verified through a review of investigation files and during an interview with the agency head.

04.01.302 policy and 01.12.120 policy are in place to ensure that allegations of sexual abuse or sexual harassment are referred for investigation to an agency with the legal authority to conduct criminal investigations, unless the allegation does not involve potentially criminal behavior. The agency published such policy on its website. This was verified through a review of the agency's website and interviews with investigative staff.

The publication on the website describes the responsibilities of both the agency and

the investigating entity.

Based on the review of policy, documentation and interviews, the facility meets compliance with this standard.

115.331 Employee training

Auditor Overall Determination: Exceeds Standard

Auditor Discussion

03.03.102 policy refers to how the agency trains all employees who may have contact with residents. The PREA training curriculum, cultural responsivity curriculum and the LGBTQI curriculum includes (1) Its zero-tolerance policy for sexual abuse and sexual harassment;(2) How to fulfill their responsibilities under agency sexual abuse and sexual harassment prevention, detection, reporting, and response policies and procedures;(3) Residents' right to be free from sexual abuse and sexual harassment; (4) The right of residents and employees to be free from retaliation for reporting sexual abuse and sexual harassment; (5) The dynamics of sexual abuse and sexual harassment in juvenile facilities; (6) The common reactions of juvenile victims of sexual abuse and sexual harassment; (7) How to detect and respond to signs of threatened and actual sexual abuse and how to distinguish between consensual sexual contact and sexual abuse between residents;(8) How to avoid inappropriate relationships with residents;(9) How to communicate effectively and professionally with residents, including lesbian, gay, bisexual, transgender, intersex, or gender nonconforming residents; and (10) How to comply with relevant laws related to mandatory reporting of sexual abuse to outside authorities; and (11) Relevant laws regarding the applicable age of consent. Training was confirmed during interviews with random staff and review of staff training records.

04.01.301 policy states that such training shall be tailored to the unique needs and attributes of residents of juvenile facilities and to the gender of the residents at the employee's facility. The employee shall receive additional training if the employee is reassigned from a facility that houses only male residents to a facility that houses only female residents, or vice versa. This was verified through a review of curriculum and training records.

Between trainings the agency provides employees who may have contact with residents with refresher information about current policies regarding sexual abuse and harassment. Per the PAQ and review of training records, staff receive PREA training on an annual basis.

The agency documents that employees who may have contact with residents understand the training they have received through employee signature or electronic verification. This was verified through review of training logs.

Based on review of policy, documentation and interviews, the facility exceeds compliance with this standard as the facility provides PREA training to staff on an

annual basis.

Auditor Overall Determination: Meets Standard Auditor Discussion All volunteers and contractors who have contact with residents have been trained on their responsibilities under the agency's policies and procedures regarding sexual abuse and sexual harassment prevention, detection, and response. This was verified through review of PREA training curriculum, cultural responsivity curriculum, volunteer handbook and volunteer and contractor training logs. This was confirmed during interviews with volunteers and contractors. All volunteers and contractors who have contact with residents have been notified

All volunteers and contractors who have contact with residents have been notified of the agency's zero-tolerance policy regarding sexual abuse and sexual harassment and informed how to report such incidents. This was verified through review of training curriculum and training records of volunteers and contractors. It was confirmed during interviews with volunteers and contractors.

The agency maintains documentation confirming that the volunteers and contractors understand the training they have received. This was verified through review of training records of volunteers and contractors.

Based on the review of documentation and interviews, the facility is in compliance with this standard.

Auditor Overall Determination: Meets Standard Auditor Discussion 04.01.301 states that residents will receive information at time of intake about the zero-tolerance policy and how to report incidents or suspicions of sexual abuse or sexual harassment and the information will be provided in an age-appropriate fashion. During the site review, the auditor observed a mock demonstration of the actual intake process and verified how the sexual safety information (PREA information/zero-tolerance information) is provided at the point of intake. This practice was confirmed during interviews with intake staff and residents. Within 10 days of intake, the agency shall provide comprehensive age-appropriate education to residents either in person or through video regarding their rights to be free from sexual abuse and sexual harassment and to be free from retaliation for

reporting such incidents, and regarding agency policies and procedures for responding to such incidents. During the site review, the auditor observed PREA posters in English and in Spanish, how to report information, and orientation handbooks provided to the residents. This practice was confirmed during interviews with intake staff and residents.

Per the PAQ, all residents are educated at intake. 04.01.301 policy requires that residents who are transferred from one facility to another be educated regarding their rights to be free from sexual abuse and sexual harassment and to be free from retaliation for reporting such incidents, and regarding agency policies and procedures for responding to such incidents to the extent that the policies and procedures of the new facility differ from those of the previous facility. This was verified through review of resident records and interviews with intake staff.

04.01.105 policy states that, resident education in formats accessible to all residents is provided, including those who are limited English proficient, deaf, visually impaired, or otherwise disabled, as well as to residents who have limited reading skills. Resident education materials were reviewed by the auditor.

The agency maintains documentation of resident participation in PREA education sessions. This was verified through a review of resident training records.

The agency ensures that key information about the agency's PREA policies is continuously and readily available or visible through posters, resident handbooks, or other written formats. During the site review, the auditor was able to observe the youth orientation handbook, PREA posters, and ombudsman contact information throughout the facility and prominently displayed.

Based on a review of policy, documentation, site review and interviews, the facility is in compliant with this standard.

115.334 | Specialized training: Investigations

Auditor Overall Determination: Meets Standard

Auditor Discussion

04.01.302 policy and 01.12.115 policy require that investigators are trained in conducting sexual abuse investigations in confinement settings. This was confirmed by review of investigator training curriculum and training records and through interviews with the investigator.

Specialized training shall include techniques for interviewing juvenile sexual abuse victims, proper use of Miranda and Garrity warnings, sexual abuse evidence collection in confinement settings, and the criteria and evidence required to substantiate a case for administrative action or prosecution referral. This was confirmed by review of investigator training curriculum and training records and

through interviews with the investigator.

compliance with this standard.

The agency maintains documentation showing that investigators have completed the required training. This was verified by review of the two investigators certifications of training.

Based on the review of policy, documentation and interviews, the facility is in compliance with this standard.

115.335 Specialized training: Medical and mental health care **Auditor Overall Determination: Meets Standard Auditor Discussion** The agency has 04.01.301 policy that is related to the training of medical and mental health practitioners who work regularly in its facilities. This was verified through medical and mental health staff training records and confirmed during interviews with medical and mental health care staff. Agency medical staff at this facility do not conduct forensic medical exams. This was confirmed during interview with medical and mental health care staff. The agency maintains documentation showing that medical and mental health practitioners have completed the required training. This was verified through a review of training logs. Training logs of medical and mental health care practitioners were reviewed to ensure they received the training for employees and contractors/volunteers (depending on their status). Based on the review of policy, documentation and interviews, the facility meets

	Per 04.01.301 policy and 04.01.302, within 72 hours of the resident's arrival at the facility, the agency obtains and uses information about each resident's personal history and behavior to reduce risk of sexual abuse by or upon a resident. The agency also obtains this information periodically throughout a resident's confinement. This was verified by a review of resident files and interviews with staff responsible for risk screening and residents. During the site review, the auditor had

staff walk through the process and do a mock intake for demonstration purposes.

PREA screening assessments are conducted using an objective screening instrument. The auditor reviewed the Risk of Victimization Screening Tool and determined it to be objective.

Interviews with staff responsible for risk screening and a review of the Risk of Victimization Screening Tool indicated at a minimum, the agency attempts to ascertain information about: (1) Prior sexual victimization or abusiveness; (2) Any gender nonconforming appearance or manner or identification as lesbian, gay, bisexual, transgender, or intersex, and whether the resident may therefore be vulnerable to sexual abuse; (3) Current charges and offense history; (4) Age; (5) Level of emotional and cognitive development; (6) Physical size and stature; (7) Mental illness or mental disabilities; (8) Intellectual or developmental disabilities; (9) Physical disabilities; (10) The resident's own perception of vulnerability; and (11) Any other specific information about individual residents that may indicate heightened needs for supervision, additional safety precautions, or separation from certain other residents.

Staff responsible for risk screening stated that this information is ascertained through conversations with the resident during the intake process and medical and mental health screenings; during classification assessments; and by reviewing court records, case files, facility behavioral records, and other relevant documentation from the resident's files, as needed.

The PREA coordinator, PREA compliance manager and staff responsible for risk screening confirmed that the agency implements appropriate controls on the dissemination within the facility of responses to questions asked pursuant to this standard in order to ensure that sensitive information is not exploited to the resident's detriment by staff or other residents. During the site review, the auditor observed that record storage is maintained securely at all times with limited access.

Based on the review of policy, documentation, site review and interviews, the facility meets compliance with this standard.

Auditor Overall Determination: Meets Standard Auditor Discussion The agency/facility uses information from the risk screening required by §115.341 to inform housing, bed, work, education, and program assignments with the goal of keeping all residents safe and free from sexual abuse. This was confirmed through review of the vulnerable risk to others decisions; Risk of Victimization Screening

Tool; and housing assignment examples, and through interviews with the PREA

compliance manager and staff responsible for risk screening.

No residents at risk of sexual victimization have been placed in isolation to keep them and other residents safe. This was confirmed through 04.01.302 policy and 05.01.303 policy and interviews with the superintendent, and medical and mental health staff. There were no residents held in isolation to interview or staff that supervise isolation.

04.01.130 policy and 04.01.303 policy states that lesbian, gay, bisexual, transgender, or intersex residents are not placed in particular housing, bed, or other assignments solely on the basis of such identification or status, nor will the agency consider lesbian, gay, bisexual, transgender, or intersex identification or status as an indicator of likelihood of being sexually abusive. This was confirmed through review of housing assignment examples and interviews with the PREA coordinator and the PREA compliance manager. At time of audit, there were no residents to interview who as LGBTI.

04.01.130 states that, when deciding whether to assign a transgender or intersex resident to a facility for male or female residents, the agency considers on a case-by-case basis whether a placement would ensure the resident's health and safety, and whether a placement would present management or security problems. 04.01.130 also states that, when making housing or other program assignments for transgender or intersex residents, the agency considers on a case-by-case basis whether a placement would ensure the resident's health and safety, and whether a placement would present management or security problems. This was confirmed during interview with the PREA compliance manager.

PREA compliance manager and staff responsible for risk screening confirmed that placement and programming assignments for each transgender or intersex resident are reassessed at least twice each year to review any threats to safety experienced by the resident.

PREA compliance manager and staff responsible for risk screening confirmed that a transgender or intersex resident's own views with respect to his or her own safety are given serious consideration.

PREA compliance manager and staff responsible for risk screening confirmed that transgender and intersex residents are given the opportunity to shower separately from other residents.

Residents are not held in isolation for risk of sexual victimization.

Per the PAQ, it is not the practice to keep youth at risk of victimization in isolation/confinement. Their housing issues would be evaluated immediately.

Based on the review of policy, documentation and interviews, the facility meets compliance with this standard.

115.351 Resident reporting

Auditor Overall Determination: Meets Standard

Auditor Discussion

04.01.301 policy and 04.01.302 policy contain established procedures allowing for multiple internal ways for residents to report privately to agency officials about sexual abuse and sexual harassment; retaliation by other residents or staff for reporting sexual abuse and sexual harassment; and staff neglect or violation of responsibilities that may have contributed to such incidents. This was verified through a review of the youth orientation handbook, PREA posters in English and in Spanish, ombudsman contact information signage, youth guidebook and PREA handouts. During the site review, the auditor observed posted or printed signage throughout the facility. Signage included audit notices, how to report sexual abuse and sexual harassment, access to outside victim emotional support services, and other relevant PREA information. The auditor reviewed the information provided on signage and determined it is readable and accessible, consistent, and placed throughout the facility to convey vital sexual safety information specific to the facility. Signage throughout the facility can be easily read/accessed by persons in the facility, specifically signage language is clear, easy to understand, and at an appropriate reading level for the persons confined in the facility. Signage specific to services, such as emotional support services and external reporting, include language that clearly details what services are available and for what purposes, and are provided at an age-appropriate reading level. Signage is provided in English and Spanish. The auditor had informal conversations with staff and persons confined in the facility regarding signage throughout the facility. The auditor was able to test internal reporting methods for the purpose of assessing whether persons confined in the facility have regular and timely access to reporting methods and how the facility receives these reports. The auditor tested reporting in writing, reporting electronically, reporting verbally, processes for sending and receiving mail, accessibility of writing instruments, and anonymously reporting. The auditor observed record storage and determined the area is secured with limited access. The was confirmed during interview with random staff and residents.

The agency shall also provide at least one way for residents to report abuse or harassment to a public or private entity or office that is not part of the agency and that is able to receive and immediately forward resident reports of sexual abuse and sexual harassment to agency officials, allowing the resident to remain anonymous upon request. Residents are not detained solely for civil immigration purposes at this facility. This was verified through review of the youth orientation handbook, PREA posters in English and Spanish, youth guidebook, PREA handout and ombudsmen reporting signage. This was also verified during site review as mentioned above and confirmed through interviews with the PREA compliance manager and residents.

Staff shall accept reports made verbally, in writing, anonymously, and from third

parties and shall promptly document any verbal reports. This was verified by review of 04.01.302 policy, youth guidebook, youth orientation handbook, PREA posters in English and Spanish and documentation of verbal reports. It was confirmed during interview with staff and residents.

The facility provides residents with access to tools to make written reports of sexual abuse or sexual harassment, retaliation by other residents or staff for reporting sexual abuse and sexual harassment, and staff neglect or violation of responsibilities that may have contributed to such incidents. this was confirmed during interviews with a resident who reported sexual abuse and the PREA compliance manager.

04.01.302 policy states that, the agency shall provide a method for staff to privately report sexual abuse and sexual harassment of residents. The auditor was able to test the staff reporting method. Staff reporting is located in the staff training curriculum. This was confirmed during interviews with random staff.

Based on the review of policy, documentation, site review, testing of processes and interviews, the facility meets compliance with this standard.

115.352 Exhaustion of administrative remedies

Auditor Overall Determination: Meets Standard

Auditor Discussion

04.01.114 policy contains an administrative procedure for dealing with resident grievances regarding sexual abuse.

04.01.114 policy allows a resident to submit a grievance regarding an allegation of sexual abuse at any time regardless of when the incident is alleged to have occurred. The policy does not require a resident to use an informal grievance process, or otherwise to attempt to resolve with staff, an alleged incident of sexual abuse.

04.01.114 policy ensures that a resident who alleges sexual abuse may submit a grievance without submitting it to a staff member who is the subject of the complaint, and such grievance is not referred to a staff member who is the subject of the complaint. The auditor reviewed a grievance form to verify this information.

04.01.114 policy requires that a decision on the merits of any grievance or portion of a grievance alleging sexual abuse be made within 90 days of the filing of the grievance. The agency always notifies the resident in writing when the agency files for an extension, including notice of the date by which a decision will be made. During this reporting period, no grievances alleging sexual abuse were received. This was confirmed during interview with a resident who reported sexual abuse.

04.01.302 policy states that third parties, including fellow residents, staff members, family members, attorneys, and outside advocates, shall be permitted to assist residents in filing requests for administrative remedies relating to allegations of sexual abuse, and shall also be permitted to file such requests on behalf of residents. If a third party, other than a parent or legal guardian, files such a request on behalf of a resident, the facility may require as a condition of processing the request that the alleged victim agree to have the request filed on his or her behalf and may also require the alleged victim to personally pursue any subsequent steps in the administrative remedy process. If the resident declines to have the request processed on his or her behalf, the agency shall document the resident's decision. A parent or legal guardian of a juvenile shall be allowed to file a grievance regarding allegations of sexual abuse, including appeals, on behalf of such juvenile. Such a grievance shall not be conditioned upon the juvenile agreeing to have the request filed on his or her behalf. This information is included in the youth orientation handbook. During the site review, the auditor observed third party reporting signage posted throughout the facility, phones were in working order, and the auditor was able to test the third-party reporting method.

04.01.114 includes procedures for the filing of an emergency grievance alleging that a resident is subject to a substantial risk of imminent sexual abuse. After receiving an emergency grievance alleging a resident is subject to a substantial risk of imminent sexual abuse, the agency shall immediately forward the grievance (or any portion thereof that alleges the substantial risk of imminent sexual abuse) to a level of review at which immediate corrective action may be taken, shall provide an initial response within 48 hours, and shall issue a final agency decision within 5 calendar days. The initial response and final agency decision shall document the agency's determination whether the resident is in substantial risk of imminent sexual abuse and the action taken in response to the emergency grievance. Per the PAQ, no emergency grievances have been filed.

The agency has a written policy, 04.01.114, that limits its ability to discipline a resident for filing a grievance alleging sexual abuse to occasions where the agency demonstrates that the resident filed the grievance in bad faith.

Based on the review of policy, documentation, site review and interviews, the facility meets compliance with this standard.

Resident access to outside confidential support services and legal representation Auditor Overall Determination: Meets Standard Auditor Discussion 04.01.302 policy states that the facility shall provide residents with access to outside victim advocates for emotional support services related to sexual abuse, by

providing, posting, or otherwise making accessible mailing addresses and telephone numbers, including toll free hotline numbers where available, of local, State, or national victim advocacy or rape crisis organizations. The facility shall enable reasonable communication between residents and these organizations and agencies, in as confidential a manner as possible. This was verified through review of the youth orientation handbook, PREA posters in English and Spanish, youth guidebook, PREA handout and the ombudsman reporting signage. This was confirmed during interviews with residents and a resident who reported sexual abuse. During the site review, the auditor observed appropriate signage throughout the facility, and was able to test reporting procedures. Phones were accessible and mail is picked up daily.

04.01.301 policy states that, the facility shall inform residents, prior to giving them access, of the extent to which such communications will be monitored and the extent to which reports of abuse will be forwarded to authorities in accordance with mandatory reporting laws. This is also contained in the youth orientation handbook and confirmed during interviews with residents and a resident who reported sexual abuse.

The agency or facility maintains memorandum of understanding or other agreements with community service providers that are able to provide residents with emotional support services related to sexual abuse. The agency maintains documentation of attempts to enter into such agreements.

05.01.106 policy states that the facility shall also provide residents with reasonable and confidential access to their attorneys or other legal representation and reasonable access to parents or legal guardians. This was confirmed during interviews with the superintendent, PREA compliance manager, residents and a resident who reported sexual abuse.

Based on the review of policy, documentation, site review and interviews, the facility meets compliance of this standard.

115.354 Third-party reporting

Auditor Overall Determination: Meets Standard

Auditor Discussion

The agency or facility provides a method to receive third-party reports of resident sexual abuse or sexual harassment. The agency or facility publicly distributes information on how to report resident sexual abuse or sexual harassment on behalf of residents. During the site review, the auditor observed third-party reporting signage and was able to test the third-party reporting process. The auditor verified the information is posted on the agency's website.

Based on the review of documentation, site review, protocol testing and website review, the facility meets compliance with this standard.

115.361 Staff and agency reporting duties

Auditor Overall Determination: Meets Standard

Auditor Discussion

04.01.302 policy and 01.12.135 policy require all staff to report immediately and according to agency policy any knowledge, suspicion, or information they receive regarding an incident of sexual abuse or sexual harassment that occurred in a facility, whether or not it is part of the agency; retaliation against residents or staff who reported such an incident; and any staff neglect or violation of responsibilities that may have contributed to an incident or retaliation. This was confirmed during interviews with random staff.

04.01.302 policy and 01.12.135 policy require all staff to comply with any applicable mandatory child abuse reporting laws. This was confirmed during interviews with random staff.

04.01.302 policy and 01.12.135 policy states that, apart from reporting to the designated supervisors or officials and designated State or local service agencies, agency policy prohibits staff from revealing any information related to a sexual abuse report to anyone other than to the extent necessary to make treatment, investigation, and other security and management decisions. This was confirmed during interviews with random staff.

During interviews with medical and mental health practitioners, they stated that medical and mental health practitioners shall be required to report sexual abuse to designated supervisors and officials as well as to the designated State or local services agency where required by mandatory reporting laws; and such practitioners shall be required to inform residents at the initiation of services of their duty to report and the limitations of confidentiality.

The PREA compliance manager and superintendent stated that upon receiving any allegation of sexual abuse, the facility head or his or her designee shall promptly report the allegation to the appropriate agency office and to the alleged victim's parents or legal guardians, unless the facility has official documentation showing the parents or legal guardians should not be notified. If the alleged victim is under the guardianship of the child welfare system, the report shall be made to the alleged victim's caseworker instead of the parents or legal guardians. If a juvenile court retains jurisdiction over the alleged victim, the facility head or designee shall also report the allegation to the juvenile's attorney or other legal representative of record within 14 days of receiving the allegation.

The superintendent stated that the facility shall report all allegations of sexual abuse and sexual harassment, including third-party and anonymous reports, to the facility's designated investigators. Investigation files were reviewed by the auditor.

Based on the review of policy, documentation and interviews, the facility meets compliance with this standard.

04.01.302 policy states that upon learning of an allegation that a resident was sexually abused, the first staff member to respond to the report shall be required to: (1) Separate the alleged victim and abuser; (2) Preserve and protect any crime scene until appropriate steps can be taken to collect any evidence; (3) If the abuse occurred within a time period that still allows for the collection of physical evidence, request that the alleged victim not take any actions that could destroy physical evidence, including, as appropriate, washing, brushing teeth, changing clothes, urinating, defecating, smoking, drinking, or eating; and (4) If the abuse occurred within a time period that still allows for the collection of physical evidence, ensure that the alleged abuser does not take any actions that could destroy physical evidence, including, as appropriate, washing, brushing teeth, changing clothes, urinating, defecating, smoking, drinking, or eating. This was confirmed through a review of first responder responses and interviews with first responders and a resident who reported sexual abuse.

04.01.302 policy requires that if the first staff responder is not a security staff member, the responder shall be required to request that the alleged victim not take any actions that could destroy physical evidence, and then notify security staff. Per the PAQ, there have been no situations where the first responder was not a security staff. This was confirmed during interviews with random staff and first responders.

Based on the review of policy and interviews, the facility meets compliance with this standard.

Auditor Discussion

Neither the agency nor any other governmental entity responsible for collective bargaining on the agency's behalf shall enter into or renew any collective bargaining agreement or other agreement that limits the agency's ability to remove alleged staff sexual abusers from contact with residents pending the outcome of an investigation or of a determination of whether and to what extent discipline is warranted. The collective bargaining document and interview with the agency head supports this standard.

Based on the review of documentation and interview, the facility meets this standard.

115.367 Agency protection against retaliation

Auditor Overall Determination: Meets Standard

Auditor Discussion

The sexual abuse and harassment response procedures protect all residents and staff who report sexual abuse or sexual harassment or cooperate with sexual abuse or sexual harassment investigations from retaliation by other residents or staff and shall designate which staff members or departments are charged with monitoring retaliation.

According to interviews with the agency head, superintendent, designated staff charged with monitoring retaliation, and a resident who reported sexual abuse, the agency employs multiple protection measures, such as housing changes or transfers for resident victims or abusers, removal of alleged staff or resident abusers from contact with victims, and emotional support services for residents or staff who fear retaliation for reporting sexual abuse or sexual harassment or for cooperating with investigations.

The sexual abuse and harassment response procedures states that for at least 90 days following a report of sexual abuse, the agency shall monitor the conduct or treatment of residents or staff who reported the sexual abuse and of residents who were reported to have suffered sexual abuse to see if there are changes that may suggest possible retaliation by residents or staff and shall act promptly to remedy any such retaliation. Items the agency should monitor include any resident disciplinary reports, housing, or program changes, or negative performance reviews or reassignments of staff. The agency shall continue such monitoring beyond 90 days if the initial monitoring indicates a continuing need. This was confirmed during interviews the superintendent and the designated staff charged with monitoring retaliation. According to the PAQ, there have been no incidents of retaliation requiring monitoring.

In an interview with the designated staff charged with monitoring retaliation, in the

case of residents, such monitoring shall also include periodic status checks.

The agency head and superintendent stated that if any other individual who cooperates with an investigation expresses a fear of retaliation, the agency shall take appropriate measures to protect that individual against retaliation.

Based on the review of documentation and interviews, the facility meets compliance with the standard.

115.368 Post-allegation protective custody

Auditor Overall Determination: Meets Standard

Auditor Discussion

Sexual abuse and harassment response protocol and 05.01.303 policy states that any use of segregated housing to protect a resident who is alleged to have suffered sexual abuse shall be subject to the requirements of § 115.342. According to the PAQ, there have not been any residents held in isolation during this reporting period. This was confirmed during interviews with the superintendent and medical and mental health staff. During the site review, the auditor did not observe any residents being held in isolation.

Based on the review of documentation and interviews, the facility meets compliance with this standard.

115.371 Criminal and administrative agency investigations

Auditor Overall Determination: Meets Standard

Auditor Discussion

01.12.101 policy related to criminal and administrative agency investigations. This was verified through a review of investigation files and during interview with investigative staff.

According to the investigative staff interviewed, where sexual abuse is alleged, the agency shall use investigators who have received special training in sexual abuse investigations involving juvenile victims.

Interviews with investigative staff interviews and review of investigation reports, investigators shall gather and preserve direct and circumstantial evidence, including any available physical and DNA evidence and any available electronic monitoring data; shall interview alleged victims, suspected perpetrators, and witnesses; and shall review prior complaints and reports of sexual abuse involving the suspected perpetrator.

According to the PAQ and investigative staff interviews, the agency does not terminate an investigation solely because the source of the allegation recants the allegation.

When the quality of evidence appears to support criminal prosecution, the agency shall conduct compelled interviews only after consulting with prosecutors as to whether compelled interviews may be an obstacle for subsequent criminal prosecution. This was verified by a review of investigative reports and interviews with investigative staff.

Investigative staff and a resident who reported sexual abuse stated that the credibility of an alleged victim, suspect, or witness shall be assessed on an individual basis and shall not be determined by the person's status as resident or staff. No agency shall require a resident who alleges sexual abuse to submit to a polygraph examination or other truth-telling device as a condition for proceeding with the investigation of such an allegation.

Investigative staff confirm that administrative investigations include an effort to determine whether staff actions or failures to act contributed to the abuse; and are documented in written reports that include a description of the physical and testimonial evidence, the reasoning behind credibility assessments, and investigative facts and findings. During the site review, the auditor observed the record storage in a secure area with restricted access. The auditor reviewed investigative reports.

Investigative staff interviewed stated that criminal investigations shall be documented in a written report that contains a thorough description of physical, testimonial, and documentary evidence and attaches copies of all documentary evidence where feasible.

Per the investigative staff, substantiated allegations of conduct that appear to be criminal are referred for prosecution. The facility reported that no criminal cases have been referred.

The agency PREA manual and investigative reports reviewed confirm that the agency retains all written reports pertaining to the administrative or criminal investigation of alleged sexual abuse or sexual harassment for as long as the alleged abuser is incarcerated or employed by the agency, plus five years.

Investigative staff interviewed stated that the departure of the alleged abuser or victim from the employment or control of the facility or agency shall not provide a basis for terminating an investigation.

When outside agencies investigate sexual abuse, the facility shall cooperate with outside investigators and shall endeavor to remain informed about the progress of the investigation. This was confirmed during interviews with the superintendent, investigative staff, PREA coordinator, and the PREA compliance manager.

Based on the review of documentation and interviews, the facility meets compliance with this standard.

Auditor Overall Determination: Meets Standard Auditor Discussion The agency PREA manual requires that the agency imposes a standard of a preponderance of the evidence or a lower standard of proof for determining whether allegations of sexual abuse or sexual harassment are substantiated. This was confirmed during interviews with investigative staff. Based on the review of documentation and interviews, the facility meets compliance

with this standard.

115.373 Reporting to residents Auditor Overall Determination: Meets Standard **Auditor Discussion** The agency has a policy, 04.01.302, requiring that any resident who makes an allegation that he or she suffered sexual abuse in an agency facility is informed, verbally or in writing, as to whether the allegation has been determined to be substantiated, unsubstantiated, or unfounded following an investigation by the agency. This was verified through review of unsubstantiated allegations and confirmed by the superintendent and investigative staff. Per the PAQ, if an outside entity conducts such investigations, the agency requests the relevant information from the investigative entity in order to inform the resident of the outcome of the investigation. DCFS notifications were reviewed. 04.01.302 states that following a resident's allegation that a staff member has committed sexual abuse against the resident, the agency shall subsequently inform the resident (unless the agency has determined that the allegation is unfounded) whenever: (1) The staff member is no longer posted within the resident's unit; (2) The staff member is no longer employed at the facility; (3) The agency learns that the staff member has been indicted on a charge related to sexual abuse within the

facility; or (4) The agency learns that the staff member has been convicted on a charge related to sexual abuse within the facility. This was verified by review of unsubstantiated allegations and interview with a resident who reported sexual abuse.

04.01.302 states that following a resident's allegation that he or she has been sexually abused by another resident, the agency shall subsequently inform the alleged victim whenever: (1) The agency learns that the alleged abuser has been indicted on a charge related to sexual abuse within the facility; or (2) The agency learns that the alleged abuser has been convicted on a charge related to sexual abuse within the facility.

The agency has a policy, 04.01.302, that all notifications to residents described under this standard are documented. The PAQ states that no notifications have been made this reporting period.

Based on the review of policy, documentation and interviews, the facility meets compliance with this standard.

115.376 Disciplinary sanctions for staff

Auditor Overall Determination: Meets Standard

Auditor Discussion

04.01.302 policy states that staff is subject to disciplinary sanctions up to and including termination for violating agency sexual abuse or sexual harassment policies.

Termination shall be the presumptive disciplinary sanction for staff who have engaged in sexual abuse. Per the PAQ, there have not been any terminations this reporting period.

03.02.108 policy requires that disciplinary sanctions for violations of agency policies relating to sexual abuse or sexual harassment (other than actually engaging in sexual abuse) are commensurate with the nature and circumstances of the acts committed, the staff member's disciplinary history, and the sanctions imposed for comparable offenses by other staff with similar histories.

03.02.108 policy requires all terminations for violations of agency sexual abuse or sexual harassment policies, or resignations by staff who would have been terminated if not for their resignation, are reported to law enforcement agencies, unless the activity was clearly not criminal, and to any relevant licensing bodies.

Based on the review of policy, the facility meets compliance with this standard.

115.377 Corrective action for contractors and volunteers

Auditor Overall Determination: Meets Standard

Auditor Discussion

03.02.108 policy and Rules of Conduct require that any contractor or volunteer who engages in sexual abuse be reported to law enforcement agencies, unless the activity was clearly not criminal, and to relevant licensing bodies. 04.01.302 policy requires that any contractor or volunteer who engages in sexual abuse be prohibited from contact with residents. Per the PAQ, there has not been any cases during this reporting period.

04.01.302 policy requires that the facility takes appropriate remedial measures and considers whether to prohibit further contact with residents in the case of any other violation of agency sexual abuse or sexual harassment policies by a contractor or volunteer. This was confirmed during interview with the superintendent.

Based on the review of policy, documentation and interviews, the facility is in compliance with this standard.

115.378 Interventions and disciplinary sanctions for residents

Auditor Overall Determination: Meets Standard

Auditor Discussion

04.01.140 policy states that residents are subject to disciplinary sanctions only pursuant to a formal disciplinary process following an administrative finding that the resident engaged in resident-on-resident sexual abuse. Residents are subject to disciplinary sanctions only pursuant to a formal disciplinary process following a criminal finding of guilt for resident-on-resident sexual abuse. The PAQ indicates that there have not been any cases during this reporting period.

05.01.303 policy states that any disciplinary sanctions shall be commensurate with the nature and circumstances of the abuse committed, the resident's disciplinary history, and the sanctions imposed for comparable offenses by other residents with similar histories. In the event a disciplinary sanction results in the isolation of a resident, agencies shall not deny the resident daily large-muscle exercise or access to any legally required educational programming or special education services. Residents in isolation shall receive daily visits from a medical or mental health care clinician. Residents shall also have access to other programs and work opportunities to the extent possible. The PAQ indicates that there have not been any cases this reporting period. This was confirmed during interview with the superintendent.

The superintendent stated that the disciplinary process shall consider whether a resident's mental disabilities or mental illness contributed to his or her behavior

when determining what type of sanction, if any, should be imposed.

Medical and mental health staff stated that if the facility offers therapy, counseling, or other interventions designed to address and correct underlying reasons or motivations for the abuse, the facility shall consider whether to offer the offending resident participation in such interventions. The agency may require participation in such interventions as a condition of access to any rewards-based behavior management system or other behavior-based incentives, but not as a condition to access to general programming or education.

04.01.302 policy states that the agency disciplines residents for sexual conduct with staff only upon finding that the staff member did not consent to such contact.

04.01.302 policy states that the agency prohibits disciplinary action for a report of sexual abuse made in good faith based upon a reasonable belief that the alleged conduct occurred, even if an investigation does not establish evidence sufficient to substantiate the allegation.

04.01.301 policy prohibits all sexual activity between residents. 04.01.301 policy and 04.01.140 policy prohibit all sexual activity between residents and disciplines residents for such activity, the agency deems such activity to constitute sexual abuse only if it determines that the activity is coerced.

Based on the review of policy and interviews, the facility meets compliance with this standard.

115.381 Medical and mental health screenings; history of sexual abuse

Auditor Overall Determination: Meets Standard

Auditor Discussion

04.01.301 policy requires that if the screening pursuant to § 115.341 indicates that a resident has experienced prior sexual victimization, whether it occurred in an institutional setting or in the community, staff shall ensure that the resident is offered a follow-up meeting with a medical or mental health practitioner within 14 days of the intake screening. This was confirmed through interview with staff responsible for risk screening. The PAQ indicates that there have been none this reporting period.

04.01.301 policy requires that if the screening pursuant to § 115.341 indicates that a resident has previously perpetrated sexual abuse, whether it occurred in an institutional setting or in the community, staff shall ensure that the resident is offered a follow-up meeting with a mental health practitioner within 14 days of the intake screening. This was confirmed through interview with staff responsible for risk screening. The PAQ indicates that there have been none this reporting period.

Any information related to sexual victimization or abusiveness that occurred in an institutional setting shall be strictly limited to medical and mental health practitioners and other staff, as necessary, to inform treatment plans and security and management decisions, including housing, bed, work, education, and program assignments, or as otherwise required by Federal, State, or local law. The auditor reviewed the HIPPA memo, mental health treatment plan and the vulnerable risk to others designation to support this standard. During the site review, the auditor observed the storage of records and found them to be secured with limited access.

Medical and mental health practitioners obtain informed consent from residents before reporting information about prior sexual victimization that did not occur in an institutional setting, unless the resident is under the age of 18. Limits of confidentiality was reviewed as evidence. This was confirmed through interviews with medical and mental health staff.

Based on the review of policy, documentation, site review and interviews, the facility meets compliance with this standard.

115.382 Access to emergency medical and mental health services

Auditor Overall Determination: Meets Standard

Auditor Discussion

Medical and mental health staff and a resident who reported sexual abuse confirmed during interviews that resident victims of sexual abuse shall receive timely, unimpeded access to emergency medical treatment and crisis intervention services, the nature and scope of which are determined by medical and mental health practitioners according to their professional judgment.

First responders stated that if no qualified medical or mental health practitioners are on duty at the time a report of recent abuse is made, staff first responders shall take preliminary steps to protect the victim pursuant to § 115.362 and shall immediately notify the appropriate medical and mental health practitioners.

Medical and mental health staff and a resident who reported sexual abuse confirm that resident victims of sexual abuse while incarcerated are offered timely information about and timely access to emergency contraception and sexually transmitted infections prophylaxis, in accordance with professionally accepted standards of care, where medically appropriate.

04.01.302 policy states that, treatment services are provided to every victim without financial cost and regardless of whether the victim names the abuser or cooperates with any investigation arising out of the incident.

Based on the review of policy and interviews, the facility meets compliance with this standard.

115.383

Ongoing medical and mental health care for sexual abuse victims and abusers

Auditor Overall Determination: Meets Standard

Auditor Discussion

04.01.302 policy requires the facility to offer a medical and mental health evaluation and, as appropriate, treatment to all residents who have been victimized by sexual abuse in any prison, jail, lockup, or juvenile facility.

Medical and mental health staff and a resident who reported sexual abuse confirmed that the evaluation and treatment of such victims shall include, as appropriate, follow-up services, treatment plans, and, when necessary, referrals for continued care following their transfer to, or placement in, other facilities, or their release from custody.

Medical and mental health staff stated that the facility shall provide such victims with medical and mental health services consistent with the community level of care.

This facility did not have female residents at time of audit.

04.01.302 policy states that resident victims of sexual abuse while incarcerated are offered tests for sexually transmitted infections as medically appropriate.

04.01.302 policy states that treatment services are provided to the victim without financial cost and regardless of whether the victim names the abuser or cooperates with any investigation arising out of the incident.

04.01.302 policy and interviews with medical and mental health staff confirmed that the facility attempts to conduct a mental health evaluation of all known resident-on-resident abusers within 60 days of learning of such abuse history and offers treatment when deemed appropriate by mental health practitioners.

Based on the review of policy and interviews, the facility meets compliance with this standard.

115.386 Sexual abuse incident reviews

Auditor Overall Determination: Meets Standard

Auditor Discussion

04.01.302 policy states that the facility conducts a sexual abuse incident review at the conclusion of every criminal or administrative sexual abuse investigation, unless the allegation has been determined to be unfounded. The auditor reviewed incident reviews and allegation reports.

The facility ordinarily conducts a sexual abuse incident review within 30 days of the conclusion of the criminal or administrative sexual abuse investigation. Incident reviews were reviewed by the auditor.

04.01.302 policy and the superintendent states that the sexual abuse incident review team includes upper-level management officials and allows for input from line supervisors, investigators, and medical or mental health practitioners.

The Superintendent, PREA compliance manager and members of the incident review team confirm that the review team shall: (1) Consider whether the allegation or investigation indicates a need to change policy or practice to better prevent, detect, or respond to sexual abuse; (2) Consider whether the incident or allegation was motivated by race; ethnicity; gender identity; lesbian, gay, bisexual, transgender, or intersex identification, status, or perceived status; or gang affiliation; or was motivated or otherwise caused by other group dynamics at the facility; (3) Examine the area in the facility where the incident allegedly occurred to assess whether physical barriers in the area may enable abuse; (4) Assess the adequacy of staffing levels in that area during different shifts; (5) Assess whether monitoring technology should be deployed or augmented to supplement supervision by staff; and (6) Prepare a report of its findings, including but not necessarily limited to determinations made pursuant to paragraphs (d)(1)-(d)(5) of this section, and any recommendations for improvement and submit such report to the facility head and PREA compliance manager. The auditor reviews several incident reviews.

The facility implements the recommendations for improvement or documents its reasons for not doing so. The auditor reviews several incident reviews.

Based on the review of policy, documentation and interviews, the facility meets compliance with this standard.

115.387 Data collection

Auditor Overall Determination: Meets Standard

Auditor Discussion

04.01.301 and the Agency PREA Manual require the agency to collect accurate, uniform data for every allegation of sexual abuse at facilities under its direct control using a standardized instrument and set of definitions.

The agency aggregates the incident-based sexual abuse data at least annually. The auditor reviewed a sample of aggregated data.

The Agency PREA Manual requires the standardized instrument includes, at a minimum, the data necessary to answer all questions from the most recent version of the Survey of Sexual Violence (SSV) conducted by the Department of Justice.

04.01.301 and the Agency PREA Manual require the agency to maintain, review, and collect data as needed from all available incident-based documents, including reports, investigation files, and sexual abuse incident reviews.

The agency does not contract for the confinement of its residents.

The agency provided the Department of Justice (DOJ) with data from the previous calendar year upon request.

Based on the review of policy and documentation, the facility meets compliance with this standard.

115.388 Data review for corrective action

Auditor Overall Determination: Meets Standard

Auditor Discussion

The agency head, PREA coordinator and the PREA compliance manager confirm that the agency reviews data collected and aggregated pursuant to §115.387 in order to assess and improve the effectiveness of its sexual abuse prevention, detection, response policies, and training, including identifying problem areas; taking corrective action on an ongoing basis; and preparing an annual report of its findings from its data review and any corrective actions for each facility, as well as the agency as a whole. The auditor reviewed annual reports which validated this provision.

Annual data reports were reviewed and includes a comparison of the current year's data and corrective actions with those from prior years and shall provide an assessment of the agency's progress in addressing sexual abuse.

The agency head stated that the agency's report shall be approved by the agency head and made readily available to the public through its website. The auditor verified this by reviewing the agency's website.

The PREA coordinator stated that the agency may redact specific material from the reports when publication would present a clear and specific threat to the safety and security of a facility but must indicate the nature of the material redacted. This was verified by reviewing annual data reports.

Based on the review of documentation, interviews and review of the agency's website, the facility meets compliance with this standard.

115.389 Data storage, publication, and destruction

Auditor Overall Determination: Meets Standard

Auditor Discussion

The agency PREA Manual and interview with the PREA coordinator confirm that the agency ensures that incident-based and aggregate data are securely retained. During the site review, the auditor observed that records are stored in a secure location with limited access.

The Agency PREA Manual requires that aggregated sexual abuse data from facilities under its direct control and private facilities with which it contracts be made readily available to the public, at least annually, through its website. This was reviewed on the website by the auditor.

Before making aggregated sexual abuse data publicly available, the agency removes all personal identifiers. The auditor reviewed a sample of publicly available sexual abuse data to check that personal identifiers have been removed.

The agency maintains sexual abuse data collected pursuant to §115.387 for at least 10 years after the date of initial collection, unless federal, state, or local law requires otherwise. The auditor reviewed the website for historical data.

Based on the review of documentation and review of the agency's website, the facility meets compliance with this standard.

115.401 Frequency and scope of audits

Auditor Overall Determination: Meets Standard

Auditor Discussion

During the three-year period starting on August 20, 2013, and during each three-year period thereafter, the agency shall ensure that each facility operated by the agency, or by a private organization on behalf of the agency, is audited at least once. Agency website was reviewed.

August 20, 2013, the agency shall ensure that at least one-third of each facility type operated by the agency, or by a private organization on behalf of the agency, is audited. Agency website was reviewed. The agency met this standard the prior year. The agency is currently in cycle four year two.

The facility provided the auditor with full access to all areas of the audited facility.

The facility provided the auditor with copies of any requested documents and information including, among other things, electronically stored information.

The facility permitted the auditor to conduct interviews with any residents that were requested by the auditor. The facility allowed the auditor to conduct these

interviews in a private setting.

Residents were permitted to send confidential information or correspondence to the auditor in the same manner as if they were communicating with legal counsel. During the site review, the auditor observed the notice of audit forms posted in all housing units. The Notice of Audit was dated with the date posted six weeks prior to the audit.

Based on the review of documentation, site review and website review, the facility meets compliance with this standard.
