#### CALL TO ORDER

1.0 The regularly scheduled meeting of the Board of Education was called to order by Acting Director, Robert Vickery on Friday, July 18<sup>th</sup> at 9:38 a.m. at the IDJJ Chicago Office.

## PUBLIC PARTICIPATION

3.0 Ms. Maleka Ingram of Adler University presented a partnership proposal to the Illinois Department of Juvenile Justice (IDJJ), aimed at enhancing mental health training and professional development for educators across the department.

The proposed training follows a three-phase approach:

- Phase I: Introductory Learning Self-paced online courses focused on foundational mental health concepts and individual reflection.
- Phase II: Interactive Practice In-person sessions featuring role-playing, collaborative exercises, and whole-group learning.

 Phase III: Implementation & Communication Launching in March 2026, this phase will support integration of mental health strategies into daily practice and school culture.

Upon completion of Phases I and II, educators will receive a digital certificate of completion. Participation is voluntary and offered as part of the department's broader professional development efforts. Adler University brings a strong commitment to serving under-resourced communities and advancing mental health equity—making this partnership a meaningful step toward supporting both staff and students.

We're pleased to welcome several new leaders to our educational community:

- Kristian May Stewart has been officially introduced as a new Board Member, bringing fresh perspective and commitment to our shared mission.
- Dr. Kimberly Kimbrough joins the team as the Assistant Superintendent of Curriculum, where she will lead instructional strategy and support academic excellence across the district.
- Ms. Traci Knisley has been named the new Principal of Monarch Youth Center.

These appointments reflect our continued investment in strong leadership and collaborative growth. We look forward to the contributions each will bring to their respective roles.

### PRESIDENT'S REPORT

4.0 The Illinois Department of Juvenile Justice is proud to announce the upcoming opening of the Monarch Youth Center, a new facility designed to support growth, healing, and opportunity for young people. The center is expected to begin serving youth in mid-September, following its grand opening celebration on September 4.

Named after the Monarch butterfly—Illinois' state insect and a powerful symbol of transformation—the facility reflects the department's commitment to moving away from correctional language and toward developmentally appropriate environments that foster positive change.

Over forty staff members have been onboarded and are currently undergoing training. The nearly completed facility was designed with a trauma-informed approach, featuring natural light, bright spaces, and a layout that is both secure and welcoming.

The Illinois Department of Juvenile Justice has expanded and now serves young adults in Department of Corrections custody who are entitled to a high school education. Led by Dr. Bambi Bethel-Leistchuh, Assistant

Superintendent of Extended Educational Services, the program currently supports 89 students with a dedicated team of six educators.

Following an electrical fire in July 2024, the Warrenville campus underwent a full renovation and is expected to reopen this fall. The updated facility will continue to serve youth with renewed infrastructure and enhanced safety features.

5.5 Starting this September, School District #428 will kick off its afterschool program, running Tuesdays and Thursdays from 4:00 to 5:45 PM. It's a great opportunity to support students with extra learning time and enrichment.

Board members have been encouraged to visit their assigned schools and connect with principals, fostering stronger relationships and deeper understanding of each school's unique strengths and needs.

### ASST. SUPERINTENDENT 6.0 UPDATE

Assistant Superintendent Summary June/July 2025

DR. BAMBI BETHEL-LEITSCHUH This school year will center around a district-wide transition to Google tools, recognizing the varied experience levels among educators. Training will be offered in three formats:

- District-wide sessions
- Building-based training
- Demonstration-based learning

These efforts aim to build confidence and consistency in using Google platforms for instruction, collaboration, and blended learning.

Similarly, the Department of Corrections will begin its own transition in December. Due to incompatibility with Windows 11, student desktops will be removed and replaced with Chromebooks.

The DJJ/DOC Diploma Program will soon onboard its seventh teacher, expanding capacity across five locations, each hosting three instructional sessions. This growth supports continued access to high school education for youth in custody.

As of now, the program proudly celebrates two graduates, with more expected as programming ramps up.

Currently, 15 positions are posted and progressing through various hiring stages. Postings will continue across all eight facilities, with full programming expected to be operational by September or October.

Weekly meetings with facility administrators and project management teams are underway, supported by Administrative Directives to guide implementation and consistency.

Professional Learning Communities (PLCs) will transition under the leadership of Dr. Kimberly Kimbrough, Assistant Superintendent of Curriculum. During the annual discussion, a point person will be identified to help guide PLC efforts.

The focus will be on:

- Curriculum updates, including intensive writing and direct instruction
- Blended learning integration, especially through Google Classroom and Connexus courses

These changes reflect a strategic shift toward more personalized, rigorous, and tech-enabled instruction.

### DIRECTOR OF SPECIAL EDUCATION

Approximately 50–60% of the student population in School District #428 is comprised of Special Education students, highlighting the importance of continued support and resources for individualized instruction.

The first cohort of the D&D Solar program has successfully completed its training, with three students preparing to graduate. Each graduate will be offered a position within the company, marking a powerful step toward postsecondary success and workforce integration. Graduation is schedule for July 30th.

The next cohort is expected to grow, expanding access to this impactful opportunity.
