#### I. Call to Order

# II. Recognition of New Board President, Candice Jones

## V Superintendent's Report

Acting Superintendent Gravatt expounded on his handouts relating:

• Vacancy needs – current staff vs. staff needed

- Superintendent Gravatt will obtain a current list of all school district epars entered to date. This information will be presented in a report to the School Board during the March meeting.
- Roadmap lists of important projects and the current status of School District 428.
- School district Report enrollment of regular and special education youth by facility, number of graduates, GED completions, etc.

The following actions were suggested at the school board meeting held on Friday February 21, 2014. The following is a list of needed actions.

- We will be conducting a nationwide search for a Superintendent of Schools.
  - Superintendent Gravatt and his staff will be obtaining a 104 job description for the position that can be electronically edited and presented to the Director and School Board members by Friday, February 28<sup>th</sup>, 2014. Each person will have until March 14<sup>th</sup> to respond with comments.
  - We will be looking into search firms to determine the costs and scope of their service. This information will be presented to the school board during the March 21<sup>st</sup>, 2014 meeting
- We are going to contact national experts to obtain advice on doing a nationwide search to fill the Superintendent position.

Motion made by Smoot to go into close session at a10:35 and seconded by Dunbar and the motion was carried.

#### Additional action and comments:

- The Board requested base line data to help understand the educational needs of the youth
- Director extended an invite for the board members to join her on a visit to St. Charles on 02/25/14.
- Superintendent Gravatt will collect baseline data on student performance to be presented to the School Board in March.
