The PREA Compliance Manager stated that the facility has a written staffing plan that is reviewed annually. The staffing plan assesses adequate staffing levels and the need for video monitoring. Compliance is reviewed through direct observation and electronic shift reports. Ratio has always been met and the facility has not deviated from the staffing plan. The facility is obligated by law to maintain staffing ratios. The facility maintains staff ratios of a minimum of 1:8 during resident waking hours. The facility maintains staff ratios of a minimum of 1:8 during resident sleeping hours, exceeding the 1:16 ratio requirement. The facility ensures that only security staff are included when calculating ratios. At least once every year the agency or facility, in collaboration with the agency's PREA Coordinator, reviews the staffing plan to see whether adjustments are needed to (a) the staffing plan; (b) prevailing staffing patterns; (c) the deployment of monitoring technology; or (d) the allocation of agency or facility resources to commit to the staffing plan to ensure compliance with the staffing plan. The PREA Coordinator stated that she is consulted regarding any assessments of, or adjustments to, the staffing plan for this facility. Staffing plan assessments occur annually and as needed. The facility requires that intermediate-level or higher-level staff conduct unannounced rounds to identify and deter staff sexual abuse and sexual harassment. 115.315 Limits to cross-gender viewing and searches Auditor Overall Determination: Meets Standard **Auditor Discussion** The facility does not conduct cross-gender strip or cross-gender visual body cavity searches of residents. The facility does not permit cross-gender pat-down searches of residents, absent exigent circumstances. Facility policy prohibits all crossgender strip searches, cross-gender visual body cavity searches, and cross-gender pat-down searches. The facility has implemented policies and procedures that enable residents to shower, perform bodily functions, and change clothing without non-medical staff of the opposite gender viewing their breasts, buttocks, or genitalia, except in exigent circumstances or when such viewing is incidental to routine cell checks (this includes viewing via video camera). Policies and procedures require staff of the opposite gender to announce their presence when entering a resident housing unit/area where residents are likely to be showering, performing bodily functions, or changing clothing. This was verified by the auditor during the site review. The facility has a policy prohibiting staff from searching or physically examining a transgender or intersex resident for the sole purpose of determining the resident's genital status. Random residents stated that they have not had a cross-gender pat-down search performed on their body and that they are able to dress, shower, and use the toilet without being viewed by staff of the opposite gender. According to random staff interviewed, staff are restricted from conducting cross-gender pat-down searches. Staff interviewed stated that staff announce their presence when entering a housing unit that houses residents of the opposite gender. Random staff stated that the facility prohibits staff from searching or physically examining a transgender or intersex resident for the sole purpose of determining the resident's genital status and that they are familiar with the policy prohibiting such actions. Staff stated that the agency has a policy prohibiting cross-gender searches and that they have received training. The Auditor verified that all security staff received training on conducting cross-gender pat-down searches and searches of transgender and intersex residents in a professional and respectful manner, consistent with security needs. Agency policy prohibits use of resident interpreters, resident readers, or other types of resident assistants except in limited circumstances where an extended delay in obtaining an effective interpreter could compromise the resident's safety, the performance of first-response duties under §115.364, or the investigation of the resident's allegations. The PREA Coordinator and random staff interviewed confirmed that the agency does not allow the use of resident interpreters, resident readers, or other types of resident assistants to assist disabled residents or residents with limited English proficiency when making an allegation of sexual abuse or sexual harassment. 115.317 Hiring and promotion decisions Auditor Overall Determination: Meets Standard **Auditor Discussion** Agency policy prohibits hiring or promoting anyone who may have contact with residents, and prohibits enlisting the services of any contractor who may have contact with residents, who has engaged in sexual abuse in a prison, jail, lockup, community confinement facility, juvenile facility, or other institution (as defined in 42 U.S.C. 1997); has been convicted of engaging or attempting to engage in sexual activity in the community facilitated by force, overt or implied threats of force, or coercion, or if the victim did not consent or was unable to consent or refuse; or has been civilly or administratively adjudicated to have engaged in the activity listed here. Agency policy requires the consideration of any incidents of sexual harassment in determining whether to hire or promote anyone, or to enlist the services of any contractor, who may have contact with residents. Agency policy requires that before it hires any new employees who may have contact with residents, it (a) conducts criminal background record checks; (b) consults any child abuse registry maintained by the State or locality in which the employee would work; and (c) consistent with Federal, State, and local law, makes its best efforts to contact all prior institutional employers for information on substantiated allegations of sexual abuse or any resignation during a pending investigation of an allegation of sexual abuse. Agency policy requires that a criminal background records check be completed, and applicable child abuse registries consulted before enlisting the services of any contractor who may have contact with residents. Agency policy states that material omissions regarding such misconduct, or the provision of materially false information, shall be grounds for termination. Human resources staff interviewed stated that the facility performs criminal record background checks for all newly hired employees, and those who are being considered for promotion, who may have contact with residents. The facility considers prior incidents of sexual harassment in determining whether to hire or promote anyone, or to enlist the services of any contractor, who may have contact with residents. Before hiring new employees or contractors, the facility consults with the State's child abuse registry system. The facility asks all applicants and employees about previous misconduct in written applications for hiring or promoting. The facility imposes upon employees a continuing affirmative duty to disclose any previous misconduct. When a former employee applies for work at another institution, upon request with a written release, the agency would disclose information on substantiated allegations of sexual abuse or sexual harassment involving the former employee. The Auditor reviewed employee and contractor files and determined that all files reviewed meet the requirements of this standard. The PREA Compliance Manager acknowledges that the facility attempts to make a victim advocate from a rape crisis center available to the victim, in person or by other means. If requested by the victim, a qualified community-based organization staff member accompanies and supports the victim through the forensic medical examination process and investigatory interviews and provides emotional support, crisis intervention, information, and referrals. The agency has a MOU with Gretchen S. Vapnar Community Crisis Center, Inc. to provide advocacy services. The agency trains all employees who may have contact with residents on the right of residents to be free from sexual abuse and sexual harassment. The agency trains all employees who may have contact with residents on the right of residents and employees to be free from retaliation for reporting sexual abuse and sexual harassment. The agency trains all employees who may have contact with residents on the dynamics of sexual abuse and sexual harassment in juvenile facilities. The agency trains all employees who may have contact with residents on the common reactions of juvenile victims of sexual abuse and sexual harassment. The agency trains all employees who may have contact with residents on how to detect and respond to signs of threatened and actual sexual abuse and how to distinguish between consensual sexual contact and sexual abuse between residents. The agency trains all employees who may have contact with residents on how to avoid inappropriate relationships with residents. The agency trains all employees who may have contact with residents on how to communicate effectively and professionally with residents, including lesbian, gay, bisexual, transgender, intersex, or gender-nonconforming residents. The agency trains all employees who may have contact with residents on how to comply with relevant laws related to mandatory reporting of sexual abuse to outside authorities. The agency trains all employees who may have contact with residents on relevant laws regarding the applicable age of consent. Training is tailored to the unique needs and attributes and gender of the residents at the facility. This was verified through interview with staff and a review of staff training files. Employees receive an initial new employee hire PREA training. The agency provides employees who may have contact with residents with refresher training about current policies regarding sexual abuse and harassment on a monthly basis. Employees also complete annual refresher training. The agency documents that employees who may have contact with residents understand the training they have received through employee signature. This was verified by the Auditor through a review of training files. During interviews, staff stated that they received PREA training at time of hire, and annually thereafter. The Treatment Unit Administrator confirmed that housing changes and emotional support services would be provided. As well, she would monitor this situation frequently for a minimum of 90 days or until the resident is released from custody. Monitoring would include reviewing resident disciplinary reports, sudden housing changes, program changes, and negative performance reviews or reassignments of staff.

The agency has a policy related to criminal and administrative agency investigations. The agency uses DJJ investigators who have received special training in sexual abuse investigations involving juveniles. The Auditor verified this during interview with the DJJ investigator. Investigators gather and preserve direct and circumstantial evidence, including electronic monitoring data, interview notes, and the resident's history. Local law enforcement gathers direct evidence, such as DNA. The agency does not terminate an investigation solely because the source of the allegation recants the allegation. The agency does not require that a resident submits to a polygraph examination. Substantiated allegations of conduct that appear to be criminal are referred for prosecution. The agency retains all written reports pertaining to the administrative or criminal investigation of alleged sexual abuse or sexual harassment for as long as the alleged abuser is incarcerated or employed by the agency, plus five years. During the site review, the auditor was able to verify that the file storage area is secured, and proper safeguards are in place.

During interview, DJJ investigative staff confirmed that they have received training specific to conducting sexual abuse and sexual harassment investigations and was able to describe specific training topics. The investigator initiates an investigation as soon as the allegation has been received. The investigator gathers all evidence, including interviews, incident reports, previous history, and video surveillance. Once sufficient criminal evidence is found, the investigation is referred to local law enforcement. Anonymous and third-party reports of sexual abuse and sexual harassment are handled in the same manner as all other investigations. A polygraph is never required. Investigations continued regardless of if the victim leaves the facility, or a staff member terminates employment. The investigation also continues even if the source of the allegation recants the allegation. A preponderance of evidence is used to make finding determinations. Investigations are documented in written form. The Superintendent, PREA Compliance Manager, and the PREA Coordinator stated that the facility remains informed of the progress of a criminal investigation by DJJ and the local law enforcement by having a facility point of contact (POC). The POC works closely with the investigative agency and communicates regularly through phone calls and emails. The facility has received five allegations of sexual harassment within the past 12 months.
