## **DIRECTOR UPDATES**

On July 31. 2020. the Pritzker Administration announced the 21st Century Illinois Transformation Model. This new model of juvenile justice was created in partnership with the Justice, Equity, and Opportunity initiative, which is spearheaded by Lieutenant Governor Juliana Stratton, and designed to reduce the harm of incarceration for youth committed to the Illinois Department of Juvenile Justice.

Since the announcement, our department has been laser focused on building capacity for the long overdue transition to community-integrated restorative justice for youth in secure custody.

As promised, we are committed to a transparent process and sharing updates along the way. We will release a quarterly Transformation Report with details on our progress, our setbacks, and how interested individuals can become involved in this transformative journey with us.

In order to ensure the success of our transformation, we are building out our Aftercare Department to provide a significant increase in community services



through our newly formed Community Services Division.

Operationally, we are moving forward with capital projects at IYC Warrenville and the new IDJJ residential center coming to Central Illinois.

We are also participating in the Pritzker Administration's Diversity, Equity & Inclusion initiative, which pairs perfectly with our efforts to reduce the harm of incarceration, particularly for Black youth who are disproportionately represented in our population.

Lastly, in partnership with the Lt. Governor's office, we are launching our first round table discussion for formerly justice-involved youth and their families to gain insight on how we can improve their experiences and better engage with families.

#### **CAPITAL PROJECTS**

With new, regional, community-integrated residential centers as one of the primary goals of the 21st Century Transformation Plan, IDJJ is making progress towards completing two new capital projects.

The first capital project is for the new residential center in Lincoln, IL. An architect is being selected for the project and selections for a contractor will follow shortly thereafter.

The second capital project is for renovations at IYC Warrenville. There have been comprehensive walk-throughs to determine the scope of the project and a selection process for an architect will take place in the coming weeks.



### COMMUNITY SERVICES DIVISION

Aftercare, IDJJ's current version of community supervision for released youth, is expanding to the department's support transformation. The new version will be called the Community Services Division and it will include Family Support and Services. Behavioral Health Residential Services. and Placement oversight, in addition to traditional Aftercare Services.

The new services will allow the department to provide increased intensive supervision, trauma responsive care, victim services, family engagement and stabilization support, and more. In the comina weeks. the department will convene working groups to gather further insight on the community supports needed by justice-involved youth and families.

# DIVERSITY, EQUITY & INCLUSION

The Pritzker Administration recently launched a Diversity, Equity, & Inclusion initiative to start dismantling racism at the state government level.

As a department, this initiative enhances our Transformation plan and helps to improve equity within IDJJ. Some of our DEI objectives are below:

- Identify treatment disparities among marginalized youth in our care
- Review and revise internal policies to reduce opportunity for biased decision making
- Develop cultural responsiveness & competency curriculum to be implemented among staff
- Monitor facility climate concerning diversity, as well as cultural responsiveness & competency
  - Invest and partner with culturally
    responsive community based resources for youth under our care

IIDJJ, in conjunction with the Lt. Governor's office, will host several round table discussions in the coming months.

Each round table discussion is geared towards a specific audience with a special focus on how they are impacted by the department.

The first round table is schedule for October 27, 2020 and is for the Families of Justice-Involved youth and Former Justice-Involved Youth.

Future round table discussions are in the works for judges and probation departments, local community leaders, service providers. iuvenile public defenders and prosecutors, juvenile justice advocates, and more.
